## **EXHIBITOR AGREEMENT FORM**

The Exhibitor agrees as follows:

- 1) In consideration for payment of the registration fee, the adequacy and receipt of which is hereby acknowledged, and execution of the 2022 ACB Convention Registration Form (the "Registration Form"), pursuant to which Exhibitor was granted the right to participate as an exhibitor at the 2022 ACB Convention (the "Convention"), the parties further agree to the following provisions as set forth below.
- 2) The sole right granted to Exhibitor pursuant to the Registration Form is the use of the reserved display space and any ancillary services purchased therein, during the dates and times, and at the location specified. No representation is made with respect to the specific location within the event space that will be provided, which shall be within the sole discretion of the event host.
- 3) The Exhibitor assumes the entire responsibility and liability for any losses, damages and claims arising out of exhibitor's activities on the Hilton Santa Fe Historic Plaza premises and will indemnify, defend, and hold harmless the Hilton Santa Fe Historic Plaza, its owner and its management company, as well as their respective agents, servants and employees from any and all such losses, damages and claims.

- 4) The Exhibitor agrees and acknowledges that it is solely responsible for all of its business and personal property, business materials, papers, currency, or any other tangible thing in, on, or about Exhibitor's event space at the Convention including, without limitation, the booth and display materials, audio-visual equipment, musical instruments and supplies, or retail items offered for sale. The Exhibitor understands and acknowledges that the the Albuquerque Concert Band ("ABQ CB"), Los Alamos Community Winds ("LACW"), the Santa Fe Concert Band ("SFCB"), the Association of Concert Bands, Inc. (the "Association") and Hilton Santa Fe Historic Plaza (the "Hilton"), their employees, officers, members, subcontractors or volunteers will not provide any security, surveillance, supervision or insurance protection for the Exhibitor's property of any kind, manner, shape or form, tangible or intangible, and that the Exhibitor attends the Convention at its sole risk and expense.
- 5) Exhibitor shall be solely responsible for maintaining Comprehensive General Liability Insurance, as well as contents coverage insurance insuring its property during the period of the Convention.
- 6) The Exhibitor agrees to defend, indemnify and hold harmless ABQ CB, LACW, SFCB, the Association, Hilton, and their respective subsidiaries, affiliates, related parties, officers, directors, employees, members, volunteers, agents and representatives and subcontractors, from and against any and all claims, damages, suits, liability, losses, personal injury or death brought by any individual or third party, and for expenses including actual costs and attorneys' fees arising in any way out of the Exhibitor's participation in the Convention.
- 7) At the conclusion of the Convention, the Exhibitor shall promptly surrender the space occupied by it in the same condition as it was in at the time the space was initially provided to the Exhibitor. The Exhibitor is responsible for all damage caused by it, its employees, officers, volunteers, agents and representatives to the exhibit area. Exhibitor is solely responsible for any property that is not cleared from the space within the time allotted by the Hilton.
- 8) The Exhibitor bears full responsibility for collection and payment of any taxes that are due from sales activities.
- 9) The Exhibitor acknowledges that it has read and understands this Exhibitor Agreement and that the individual signing on behalf of the Exhibitor is at least 18 years of age and is an employee, officer, owner, or agent of the Exhibitor will full authorization to bind the Exhibitor and sign this Agreement.
